- Step 1. Print your name on the first line of the Stock Will.
  - This must be done to make the Stock Will valid
  - If this line is left blank, the Stock Will becomes void
- Step 2. Complete the rest of the section with your
  - Date of birth
  - Social Security number
  - Address
- Step 3. List your designated heirs
  - Name
  - Social Security Number
  - Relationship to you
  - List % of shares each heir is to receive (Total + 100%)
    - This must be done in a percentage format, please do not list number of shares because this will make your will void. Below is a "Sample Guide" of percentages you may used when completing your Stock Will.
      - 1 person 100%
      - 2 persons 50% -50%
      - 3 persons 34%- 33% -33%
      - 4 persons 25% 25% 25% 25%
      - 5 persons 20% 20% -20% 20% -20%

The Notary of the two (2) witnesses (18+ years) you are using to confirm your Stock Will CAN NOT be listed as heirs.

Step 4. Sign and date the Stock Will in front of a notary and sign in front of two witnesses.
